“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. Austin & San Antonio’s 2018 “Lawyer of the Year” section features Jim Walsh, shareholder at Walsh Gallegos Treviño Russo & Kyle P.C., who was named the 2018 Education Law “Lawyer of the Year” in Austin. Walsh has previously been named the Education Law “Lawyer of the Year” in Austin by Best Lawyers in 2016 and 2013.
