For research purposes, Indiana is comprised of eight metro areas: Carmel, Chicago, Illinois, Columbus, Evansville, Fort Wayne, Indianapolis, Louisville, and South Bend.

“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. Indiana’s 2018 “Lawyer of the Year” section includes a feature on Donald R. Lundberg, principal of Lundberg Legal, who was named the 2018 Ethics and Professional Responsibility Law “Lawyer of the Year” in Indianapolis.
