For research purposes, Texas is comprised of nine metro areas: Austin, Beaumont, Corpus Christi, Dallas/Fort Worth, El Paso, Houston, Lubbock, San Antonio, and Tyler.

“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. Texas’ 2018 “Lawyer of the Year” section includes a feature on Robert Latham, partner at Jackson Walker LLP, who was named the 2018 Sports Law “Lawyer of the Year” in Dallas/Fort Worth.
