“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. Colorado’s 2019 “Lawyer of the Year” section includes a feature on Lesleigh Wiggs Monahan, partner at Polidori, Franklin, Monahan & Beattie, LLC., who was named the 2019 Family Law “Lawyer of the Year” in Denver. Monahan was previously recognized as the Family Law “Lawyer of the Year” in Denver by Best Lawyers in 2016 and 2018.
