For research purposes, the Washington, D.C. metro area is comprised of 42 cities from the surrounding area, including cities in Virginia and Maryland.

“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. Washington, D.C.’s 2019 “Lawyer of the Year” section includes a feature on Elizabeth B. Meers, partner at Hogan Lovells LLP, who was named Washington, D.C.’s 2019 Education Law “Lawyer of the Year”.
