New England is comprised of six states: Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont.

“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. New England’s 2019 “Lawyer of the Year” section includes a feature on Annette Gonthier-Kiely, founder of Annette Gonthier-Kiely & Associates, who was named the 2019 Medical Malpractice Law - Plaintiffs “Lawyer of the Year” in Boston.
