The metro areas included are: Stamford, CT, Hackensack, NJ, Newark, NJ, Woodbridge, NJ, Long Island, NY, New York, NY, and White Plains, NY.

“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. New York’s 2019 “Lawyer of the Year” section includes a feature on Anthony J. Enea who was named White Plains’ 2019 Trusts and Estates “Lawyer of the Year”.
