For research purposes, smaller and more rural cities located within a reasonable distance to larger cities are combined into single geographical regions called “metro areas” to help collect as much feedback and data as possible. “Lawyer of the Year” awards are designated through these metro area distinctions. Pennsylvania is comprised of five metro areas: Allentown, Pa., Cherry Hill, N.J., Harrisburg, Pa., Philadelphia, and Pittsburgh.

“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. Pennsylvania’s 2019 “Lawyer of the Year” section includes a feature on Kevin R. Casey, chair of the intellectual property and the IP litigation groups at Stradley Ronon Stevens & Young, LLP, who was named the 2019 Trademark Law “Lawyer of the Year” in Philadelphia.
