The South Florida area is comprised of four metro areas: Fort Lauderdale, Fort Myers, Miami, and West Palm Beach.

“Lawyer of the Year” honorees are based on extremely high overall feedback within specific practice areas and metropolitan regions. South Florida’s 2019 “Lawyer of the Year” section includes a feature on Bruce L. Udolf who was named Fort Lauderdale’s 2019 Criminal Defense: General Practice “Lawyer of the Year”.
